Additionally, many civilian casualties were treated for severe dehydration and malnourishment. Care rendered at the Advanced Life Support level in accordance with Tactical Combat Casualty Care Guidelines.
- In cases of the most critical patients, when resources permitted, I transported patients via ambulance 30-60 minutes to Coalition, MSF, and ICRC hospitals.

Trainer/Advisor, Austere Medical Initiative - NGO (Sinjar, Kurdistan), May 2017-June 2017

- I worked as an instructor and advisor for a capacity building effort with Peshmerga units in Sinjar. Pre-mission responsibilities included development of curriculum and training materials, coordination with additional trainers, and onboarding for our Kurdish translator. The project provided TCCC classes to several Peshmerga units as well as several train-the-trainer courses to allow continued education once western trainers had left. Primary care clinics were run on two bases by myself and another provider to meet the needs of multiple patients that presented.
- Prior to arrival in Kurdistan responsibilities included risk identification and mitigation, communication and evacuation planning, and medical supply procurement.

Safety Guide, Discovery Network (British Columbia, Canada), October 2016-January 2017

- As one of two safety guides and medical providers for a cast and crew of more than 40 people filming a survival television program in the Canadian Rocky Mountains I was responsible for sick call, emergency response, risk management, medical logistics, and evacuation planning.

- I managed a multidisciplinary team comprised of physicians, paramedics, nurses, logisticians, and IT professionals to ensure delivery of emergency and primary care services for a refugee camp in Northern Greece. The nearly 500 camp residents were families from Syria and Kurdistan many of which had chronic or specialized medical needs unable to be met in the larger camps.
- As team leader I supervised delivery of all primary and emergency care required by camp residents ensuring it adhered to WHO standards, coordinated with multiple specialized NGOs to provide additional care (OBGYN, Dental, Psychological), managed relationships with International Organization for Migration – Greece and UNHCR, and directly handled logistics for local purchase and procurement of supplies and medications as well as import of the same. As needed, I rendered patient care as well.

Instructor, National Center for Security & Preparedness (New York), May 2016-February 2021

- Through a partnership with the National Center for Security and Preparedness and the New York State Department of Homeland Security and Emergency Services I instruct members of public safety from across New York State and a number of federal agencies in the areas of Tactical Emergency Casualty Care and operational medicine.
- Courses taught include Advanced Active Shooter Scenarios, EMS Special Situations, Land Navigation, Rescue Task Force, and Team Tactics for Patrol Officers.
- I have also contributed as a subject matter expert for modules in-development covering Casualty Collection Point management, blast injuries, prolonged casualty management, and multiple casualty incidents.

- The scope of practice for a New York State EMT-Critical Care includes narcotic pain management, endotracheal intubation, medication facilitated intubation, ACLS/PALS, IV/IO access, and 12 lead EKG interpretation.
- I took on additional responsibilities in community relations and overseeing a special operations support team. In those roles I routinely represented the agency at meetings with the media and public safety agencies.
